### CRDC 2017-2018 Collection Update

Updates for the 2017-2018 CRDC Collection went out this week in a patch release. *There's still time to register for tomorrow's CRDC Collection Workshop!*

## Support Announcements

### March SIMS Report

Friday is March 1. If you have not already started, Massachusetts districts should be actively reviewing their validation errors and working to resolve them. The Certification deadline is March 21 and the Re-Certification deadline is March 28.

Make sure that you have updated the DOE Parameters > Last Transmission Date to 03/01/19 at all your schools. This will set the SIF "As of Date" for the SIMS transmission. If you have to modify the date from 10/01/2018 to 03/01/2019, make sure that you send the SIMS Objects to DESE. Use Delete SIF Temp Table to clear the StudentPersonal and StudentSchoolEnrollment objects and use Send SIF Objects to send up-to-date data. If you made adjustments to summer withdrawal records you will also need to send the summer withdrawal objects.

Along with clearing errors, districts should confirm they are reporting all of their enrolled students. To help identify all enrolled students that should be reported, be sure to check out these helpful resources:

- The Enrolled Student Report DOE NO query. This query will find all enrolled students set to Report to DOE = No. Go to iPass Help > My Queries > Query Files for Download > [Enrolled Students Report to DOE](#). If the student will not stay set to Report to DOE = Yes, [check to make sure the SASID format is correct](#). The Report to DOE field can now be mass-updated using Biographical System > Mass Update Students > SIF Report to DOE.
- The Enrollment Reconciliation Report. Upload to iPass your SIMS Transmission download file from the DESE Security Portal and run this report to compare the download file to the enrolled students in iPass. The report will provide a list of students that are missing from the SIMS Transmission file. Go to iPass Help > DOE ID Manager > Help > [Enrollment Reconciliation Report](#).
- DESE Security Portal > SIF Reports > SIF Transmission Reports > District Reports. [MA DESE Resource: Guide to SIF Transmission Reports \(Nov 30 2017\)](#).
  - The Counts of SIF Objects report provides the number count for StudentPersonal and StudentSchoolEnrollment records sent in the transmission.
  - District Student Roster
  - SIMS – Individual SIMS Record (look up by SASID)

DESE Security Portal > SIMS Transmission Report. Download the SIMS Transmission report to see which students are included in the SIF transmission and the associated code values.

Once your errors are cleared and your enrollment count is confirmed, SIF districts should freeze their data and check all SIMS Reports for data accuracy.

## **New SIMS Validations**

DESE has announced that they will be deploying several new SIMS validations this week. Please see summary below.

### **2910 – IRC previously reported in DOE047, must continue to be reported.**

If in the prior collection, a significant value was reported in DOE047, then it must continue to be reported.

- Elements affected: DOE047 - Industry Recognized Credential
- This validation previously looked back to EOY DOE031 and now will look back to the previous collection's DOE047.

### **8395 - HQCP Program Type (DOE045) is not offered in student's school.**

The enrolling school (DOE015) does not offer the HQCP program reported for the student.

- Elements affected: DOE045 - HQP Program Type, DOE015 - School.
- OCT, MAR, EOY

### **8396 - School offers Innovation Pathways HQCP program but no students are reported participating.**

- The enrolling school (DOE015) offers an Innovation Pathways HQCP program, but no students have been reported as participating (DOE045=01).
- OCT, MAR, EOY

### **8397 - School offers Early College HQCP program but no students are reported participating.**

- The enrolling school (DOE015) offers an Early College HQCP program, but no students have been reported as participating (DOE045=02).
- OCT, MAR, EOY

### **2970 Previously reported Early Childhood Experience (DOE050), if accurate, must continue to be reported.**

If in the previous collection, an applicable value (not 99) was reported for this student, then an applicable value must continue to be reported, if accurate

## iPass Releases & Updates

### Patch Release – 7.0.20190225\_sync

A patch release went out on February 25, 2019 (v. 7.0.20190225\_sync). The patch release included several updates and corrections. Please refer to the Release Notes for full details. The Release Notes have been posted in the iPass Support Hub Knowledge Base and in iPass Help > [iPass Patch Release Notes](#).

#### Patch Release Highlights:

- **Updates for 2017-2018 CRDC Collection**
- **SIF SDR:** The DisciplineIncident Object now includes the Description of Offense Type 1-5 for iPass Incident codes mapped to SIF Offense of 1897 (Other nonsexual harassment), 2797 (Other school threat), 3197 (Other theft), 3297 (Other threat), 3597 (Other vandalism) and 3600 (Violation of School Rules). **Action Required:** If you are receiving Error SDR4570: If Optional Description Code selected for Offense 1, a description is required, use Delete SIF Temp Table to clear the DisciplineIncident Object and then use Send SIF Objects to send all of the DisciplineIncident Objects for your district or use SIF Reporting > SDR to send for specific schools and/or student SASIDs to clear the errors

### Upcoming Patch Release

The iPass Team is preparing another patch release that will include enhancements to Teacher Behavior Referrals to add a Teacher Action and Teacher Comments field and add a Discipline Parameter to select the Incident Codes available for teachers to select. A new Liaison field option has been added as well.

## iPass Tips & Tricks

### Hiding 2019-2020 Schedules from Parents, Students & Teachers

Don't forget to make sure that next year schedules are not available in the iParent and iStudent View Schedule and View Grade screens.

The iParent and iStudent Configuration must be set to Show Schedule = Current & Prior and Show Grades = Current & Prior. If set to All, they can see the 2019-2020 courses when they select the next school year.

If you want to hide future schedules from teachers you need to make sure your District Configuration is set to Show Schedules = Current & Prior. Then use the Assign Teacher Access feature to give individual school administrators and guidance counselors access to future teacher schedules and future student schedules.

## **SSDR: Error List Appendix A – List of Offense Codes**

On [DESE's SSDR reference page](#) the SSDR Error List includes a very helpful resource: the Appendix A – List of Offense Codes lists all the Offense codes and indicates for each code whether it is Always Reportable, Victim Count Required, Description Required, and Physical Injury Indicator Required. We have posted this in the iPass Support Hub Knowledge Base and in iPass Help > DOE ID Manager > Help > SSDR subcategory folder > [SSDR Error List Appendix A – List of Offense Codes](#).

## **Support Tickets – Check the Suggested Solutions**

When you create a new support ticket in the iPass Support Hub the Submit a Ticket screen will provide users with Suggested Solutions. As you type in your support issue the Knowledge Base will make recommendations based on the key words you type in the Ticket Description box. Scroll down to the bottom of the Submit a Ticket screen to view the suggested Knowledge Base articles. Click on any of the listed suggestions to open the Knowledge Base item.
