## **DOE039 New Field named 504 Plan Status**

\*\*\*\*\* Go to <DOE ID Manager><Mass update> and Set the enrollment to All and scroll all the way to the bottom of screen to the field <**DOE039 DISCONTINUED:**> (there are two fields for this make sure you are all the way at the bottom of the screen) Set it to Does Not Apply and click submit. After the report is done running go to <DOE ID Manager><Maintenance DOE><Fields> and click on <**DOE039: DISCONTINUED**> Delete all codes except the 500 Does not Apply. Change the 500 code to 00 and the description to what is below and the state code to 00. Then add the code 01 with its description and state code of 01. Then set the name, description and Label to be **DOE039 504 Status: \*\*\*\*\***

00: If the student not in a 504 plan during the school year

01: If the student was in a 504 plan during the school year

\*\*\*\*\* Now go to <DOE ID Manager>< Mass Update> and set the enrollment to enrolled and the first field of <**SPED Placement Ages 6-21- DOE034:**> to the 504 code. Then scroll to the bottom and set the field <**DOE039 504 Status:**> to the code 01 Student was on 504 Plan during the school year and click the submit button. Now all 504 students will be set to 01 in this new field.\*\*\*\*\*

### **New Job Classification Codes**

Two new job classifications will be added for October 1, 2011:

## **Alternative Education Programs**

Starting in October, alternative education programs can be reported in EPIMS and SCS as the location where a course is taught **if the course is not taught in a school**. If the course is taught in a school, the school code must be used for WA06 and SCS03.

In EPIMS, WA06 will be changed to identify the location where a course is taught, similar to SCS03.

Districts will be able to report school codes or valid 8-digit district alternative education program codes in both WA06 and SCS03.

District alternative education program codes **must be registered with ESE**.

\*\*\*\* Use the MA VHS Course ID: field in the course catalog sections schedule screen like you do for VHS courses. Enter the appropriate 8-digit code for the Alternative Education program the course is taught at. \*\*\*\*

## **To Make EPIMS Exports for 10/01/2011**

You will not see EPIMS work assignments for staff until you follow these steps.

Go to < iStaff Biographical><iStaff Procedures><iStaff Configuration> set the EPIMS as of date to 10/01/2011.

Go to < iStaff Biographical><iStaff Procedures><Export EPIMS data> and run an export with recalculate FTE set to YES.

Go to < iStaff Biographical><iStaff Procedures><EDIT EPIMS Work Assignments> and go through the EPIMS work assignment records and post the records for each staff person.
