iPass Enhancements

The February patch release included many enhancements, updates, and corrections. Please take time to review the Release Notes and highlights below. Join us next week at the March User Group meeting as we review the updates.

Support Announcements

Massachusetts March SIMS

Now that March 1 has arrived, SIF districts can begin to submit their March SIMS data, work to clear errors, and certify by the March 23 Certification deadline.

Resources to help you with SIF/SIMS state reporting can be found in iPass Help > DOE ID Manager > Help > SIMS (MA) > Helpful Hints Guide – March SIMS 2017 and iPass Help > SIF.

Reminders for SIF districts:

- The goal should be to freeze your data as soon as you are error free.
- Make sure each school's DOE Parameter for the Last Transition Date is set to 03/01/2017.
- Check your student record count in the DOE Security Portal.
- Use the Security Portal SIMS Transmission Download feature to get a file of all reported student and associated SIMS 52 data element codes transmitted through SIF.
- Use the new Enrollment Reconciliation Report to find the students who are enrolled in iPass but not in the SIF transmission records at the DOE. *(See iPass Tips and Tricks section below for more detail.)
- In the event that a student reported in October was changed to a summer withdrawal, in order to update the DOE on the student's enrollment status as a summer withdrawal you will need to push the summer transfer data to the DOE.
- Remember to keep checking the DOE Security Portal to see if your errors have cleared.

iPass Tips & Tricks

Enrollment Reconciliation Report

SIF districts should check for students who may be missing from the SIF SIMS transmission. Download the SIMS Transmission file from the DOE Security Portal. Upload it to iPass and run the "Enrollment Reconciliation Report" to find the students who are enrolled in iPass but not in the SIF transmission records at the DOE. The report will show the Student ID#, SASID#, and School Code. More information can be found in iPASS Help > SIF > Help > Enrollment Reconciliation Report.

What makes a student get reported in the Enrollment Reconciliation Report?

These are students who are missing in the MA SIMS Transmission file that iPass expects to be reported. Running the report compares what iPASS would report in a SIMS 52 Export Legacy file for that report date (based on DOE Parameter Last Transmission Date) to what the DOE has in the SIMS Transmission download file. iPass looks at the Primary School/Year Record (School Year, School, Grade Level), the Enrollment Record

(Enrolled, Withdrawn, TRF, summer withdrawal date), and Report to DOE = Yes. Students who are NOT in the DOE's SIMS Transmission download file will be listed in the report. These students are missing in your SIF transmission.

NOTE: If there are summer withdrawals in the report, you will need to push the SIF Objects for Summer Transfers: SummerWithdrawals-StudentPersonal and SummerWithdrawals-StudentEnrollment.

iPass Releases & Updates

A patch release (v. 7.0.20170223_sync) went out on February 23 to all Sync version sites. The release includes enhancements, updates, and corrections.

Application enhancements/updates include:

• A new option to configure Online Course Recommendations by Grade Level.

IMPORTANT NOTE: All districts need to set up the Recommendation
Configuration by Grade Level. Please refer to the updated iPass Help >
Scheduling > Help > Administrator's Quick Start Guide for Configuring Student
Course Recommendations (February 2017) for directions.

- A new option to add and report Guardian CORI Check information and Date of Last CORI.
- Teachers now can select to view previous and future years in My Courses > Gradebook.
- Students who "Dropped" a course:
 - o Gradebook will display red # symbol next to dropped student name.
 - The Enter Period Attendance class roster will no longer include students who dropped the course during the term as of the course "Drop Date."
- Updates For:
 - 2016-2017 Clever Export.
 - o 2015-2016 Civil Rights Data Collection (CRDC).
 - 2016-2017 SSDR SIF Mapping option for Incident Code MA19 Felony Complaint Outside of School.
