

Patch Release Notes - 7.0.20160928_sync

A patch release (v. 7.0.20160928_sync) went out on September 28th to the Massachusetts and Pennsylvania Sync Version sites. The patch addressed included several enhancements and corrections including the following:

Enhancements:

- Create iStudent Account “ A new option has been added to iStudent Configuration that allows end users to create iStudent accounts, append existing accounts, and create iStudent email addresses.
- MA State Reporting:
 - New field to identify “Scheduling School” (SIF)
 - New “Gender “ DOE009” field to accommodate new Nonbinary Gender
 - New “Homeless” field (SIF)
 - New “SLIFE “ DOE041” field
 - New “Non-Graded” Course indicator added to Course Details screen (SIF)
 - New Warning message if end users change the DOE011, DOE012, DOE013 fields without exiting or enrolling the student
 - New ability to restrict the row count for SIF Log files
 - New “SIF Report” screen allows user to send SIF Objects by School (all reports) by Individual Students (SIMS, SCS, SSDR), by Course- Sections (SCS), or by individual staff members (EPIMS)
- PA State Reporting:
 - Updates made to the PIMS Student Fact Template “ Special Education for the Act 16 Report.

Corrections and Minor Enhancements Made To:

- The “Add” button is now available for all grade levels in

Transcript History. This will allow the end user to enter a transcript record for a first year student.

- When creating a school calendar the school Start and End Dates have been extended to include additional future years.
- The iParent Schedule Rotation view will now initialize on the current term and will no longer reflect a blank report on the initial login.
- Add/Modify Student Grades will now display all of the courses scheduled for the selected term.
- The Massachusetts eSPED export will now reflect the student's LASID.
- Student Bio Verification Report will no longer print blank pages and will print a copy for siblings at the same school.
- Massachusetts Discipline reports will now render data regardless of corrupted return dates.
- Employee ID has been added to the "Import Staff Data" parameter page instruction. The screen now displays the 6 required fields for import (Employee ID, First Name, Middle Name (NMN), Last Name, DOB, Gender).
- Letters are now printing as expected with correct page breaks within the Letter Module.
- iHealth Reports > Letters is now honoring the selected grade levels when printing.
- My Courses > Gradebook view shall now reflect a student's period absence code in the assignment grade field if the student was absent on the assignment due date.
- Student Profile > Date of Birth month calculation will display the correct Years and Months.
- EPIMS Reporting " iStaff Batch Entry screen will now allow an input equal to zero (0), for staff members reported on leave.
- Quick Scheduling " Associated courses in the Room Catalog can now be deleted.
- Guardian Information displays multiple email addresses entered for a Guardian with email address rank.

- Gradebook/Rankbook Progress Reports will no longer reflect students who have dropped the course-section.
- The Submit Course Grades screen in the Gradebook will now reflect all students for the course-section.
